### **Technical Translation**

#### **Moscow Oil Refinery**

Translation of technical documentation for construction of the Euro+ oil refining unit at the Moscow Oil Refinery, which supplies 38% of the fuel needs of Moscow Region. Translation rate was up to 500 pages per day.

#### **Kstovo Oil Refinery**

Translation services for an international group of companies working on design, installation and licensing of equipment for oil residue processing at the Kstovo Oil Refinery. Translation of documents in all formats, including AutoCAD and InDesign.

#### **Arctic terminal**

Translation of technical documentation for construction of a year-round oil shipment terminal serving the Novoport field in the Russian Artic. Translation of materials at all project stages, from tender documentation, feasibility study and FEED to project documentation, including as-built drawings.

#### Arctic LNG-2
